To facilitate efficient operation, the Council established several committees; the Audit Committee, Finance, Corporate Affairs & Human Resource Committee, Professional Standards Committee, and the Strategy Committee.

The Board Evaluation undertaken in 2023 indicated excellent performance score of 93.2% up from 74.96 in 2022 and 62.82 in 2021.

To improve complaint resolution, the Disciplinary Committee undertook training in Alternative Dispute Resolution (ADR) techniques for handling complaints. The training emphasized the committee's dedication to fostering a more effective complaint process.

Furthermore, she emphasized the committee's commitment to developing a comprehensive Investigation Manual. They are pleased to report that funding for this project, in collaboration with relevant agencies (PPRA, EACC, DCI, and ODPP), has been approved by PFMR for the year 2024.

He reported significant financial growth in 2023, increased revenue, reflecting the continued effectiveness of the business model. The surplus grew substantially, positioning the Institute well for future investments and strategic initiatives

CM. Fidel Muema underlined their commitment to ensuring timely access to financial reports. The reports for the year ending 2023 will be made available to members well within the stipu-

lated deadlines. This will allow for thorough review and facilitate a more productive Annual General Meeting (AGM) with member engagement.

To ensure ongoing oversight, the responsibility for monitoring the Framework's implementation by Management has been entrusted to the Council's Audit and Risk Management Committee.

CM. Jeremiah Nthusi, the chairperson of the strategy committee emphasized that the institute's impact has been significantly amplified by fostering strong strategic partnerships. These partnerships have been instrumental in cultivating a culture of continuous learning, professional excellence, and global collaboration.

He provided an update on several key initiatives: Development of a Regional Chapter Governance Policy, informed by consultations with members nationwide, Launch of the Kenya College of Supply Chain Management (KCSCM), a TVET-registered institution that will offer training programs in: Certified Procurement and Supply Professional of Kenya (administered by KISEB), Qualifications from the Chartered Institute of Procurement and Supply (CIPS) and Qualifications from the Chartered Institute of Logistics & Transport (CILT) International"

And most important was the onboarding onto the Performance Contract 2024 under the National Treasury.

Workshop on the Role of Environment, Social Governance (ESG) and Diversity, Equity And Inclusion (DEI) in Procurement and Supply Chain Management

Mr. Matiba (KISM CEO) emphasized KISM's role in promoting learning, best practices, and professional development in procurement and supply chain management through licensing and regulation of professionals in the field. He underscored the significance of ESG principles in mitigating global supply chain risks and promoting sustainable practices, while emphasizing the importance of DEI in fostering inclusivity.

He referenced the Government's support for DEI initiatives such as the Access to Government Procurement Opportunities (AGPO) and highlighted the constitutional provisions for protecting vulnerable groups in procurement.
