- 2. Recognizing that the 1st Certificate Award Ceremony was held in 2019 with only 3 candidates being awarded full certification, I join the rest of the speakers in congratulating KISEB for the transformative interventions and concerted efforts in the delivery of its Programmes.
- 3. I also extend my heartfelt appreciation to the KISEB Board and KISM Council for their unwavering commitment to investing in sustainable collaboration and partnership beneficial to both institutes.
- 4. Indeed, this collaborative approach aligns perfectly with the rebirth of a new philosophy at the Institute which we are proposing to our

internal and external stakeholders, and thus Delivering – As One, And With All.

- 5. Ofcourse for KISEB and KISM we are children of the same mother....both our Institutions are a creation of the Suppliers Practitioners Management Act, 2007. - 12. I am greatful to all our members present, and our stakeholders, in the past 1 month since the time the Institute issued a Compliance Circular to all public entities to reinforce compliance with requirements of the Suppliers Practitioners Management Act, we have continued to register quite a number of new applications at the Institute.
- 13. This is a gesture of confidence, and I am greatful. During this period we have been

above to successfully process over **700 new** applications.

- 14.I therefore wish to encourage all graduands here today, to register with the Institute and ensure you remain in good standing. Some of you who are new in the Supply Chain Management Practice, it is a worthwhile career key for the social economic progress of the Country.
- 15. You must therefore have the right attitude and embody values of selfleness in service delivery, be agile and innovative to fit in this competitive and complex career.
- 16.I am confident that the training you have received meets the regulatory requirements

and is relevant to the contemporary market expectations.

- 17. As we congratule you, we also recognize the sacrifices and support offered by the Institute's staff, parents, guardians, sponsors and other stakeholders, who have made this ceremony a reality.
- 18. I wish to challenge the awardees to confidently proceed and deploy the knowledge and skills you have acquired for the benefit of society. While exercising integrity and professionalism, show passionate focus as you engage in your career path with a future-oriented approach of accountability and credibility. In addition, strive to further your education in this area of

Supply Chain Management.

expertise to meet emerging challenges headon. We also encourage our practitioners to comply with the laws that govern the Supply Chain Management space.

To the our Members Present,

22. I wish to assure that the Institute, we are committed to transforming **KISM to be a model institution** that delivers to the expectation of its members and stakeholders.

23. Our priorities now include;

 First, to make the Institute efficient, effective and accountable in service delivery by being members-focused.

I aware there have been challenges around **administrative delays processing membership services.**

From the beginning of April to-date we have been able to clear a backlog of

over 1,000 membership applications at the Institute.

The good news is that we are **digitizing our core business processes** to have a long lasting mitigation to the members concerns. **I thank the World Bank** for partnering with the Institute in this journey of reengineering our core business processes.

ii. Second, to create a condusive working environment that yields impactful programmes.

We have now **operationalized the Kenya College of Supply chain Management,** and from this month we are admitting students. Our desire ultimately will be to have all practitioners in the Country to have **CPSP-K qualifications.** 1st **January, 2025 date.....**

iii. Third, to contribute to the positioning the supply chain profession in Kenya for greater relevance and credibility.

We will strongly engage relevant stakeholders to **make our members feel adequately empowered, as we work with other professions in contributing to** matters of national interest.

We will **advocate within the available structures** for welfare, equity in employments, appointments and 'killing the negative stereotyping of Supply Chain Professionals"

This week, we will be **revamping our regional chapters**, to make our services available at the grassroot levels. We are also empowering our key organs, such as the **Disciplianry Committee** to take up matters of professional misconduct in line with our establishing Statutes.

Just a fortnight ago, we were able to work with the Judiciary through the Kenya Judiciary Academy to build the capacity of our Disciplinary Committee.

24. As I conclude, I wish to convey my sincere gratitude to all the stakeholders present for heeding our call to join us for this award ceremony. I specifically wish to appreciate the presence of representatives from the Estonian Embassy and from KCA University for being here with us today.
