iii. To contribute to matters of national interest and promotion of good governance. For the first time, we have the disciplinary arm of the Institute fully functional.

The Institute, working with the Judiciary and other actors has now satisfactorily built the capacity of its disciplinary wing to handle matters of professional misconduct.

- iv. To translate feedback into continuous improvement as we seek to serve our members better. We have made our position clear, on compliance enforcement. We are working very closely with other regulatory institutions in this regard. This has seen our membership grow to over 10,000 in the recent past.
- v. To strengthen our institutional capacity, by having structured programs including on emerging topics.

  The focus is now two-fold, characterized by the modeling of both public and private sector-oriented programs.
