## NOTICE TO MEMBERS NOT IN GOOD STANDING

The Procurement and Supply Chain Management profession in Kenya is governed by the provisions of the Supplies Practitioners Management Act, No. 17 of 2007, together with the attendant Supplies Practitioners Management Regulations.

**THAT PURSUANT** to the provisions of Sections 19, 20, and 21(3) of the Supplies Practitioners Management Act, No. 17 of 2007, read together with Regulations 16, 17, 18, 19, and 20 of the Supplies Practitioners Management (Registration and Licensing) Regulations, the Institute hereby notifies all members who were not in good standing in the year 2025 to regularize and update their membership status within **fourteen (14) days** from the date of this notice.

**FURTHER TAKE NOTE** that failure to comply within the stipulated period will result in **deregistration** in accordance with the provisions of the Supplies Practitioners Management Act, 2007 and its attendant Regulations.

**IT IS FURTHER EMPHASIZED** that Members who were **not in employment during the period under review** are advised to formally notify the Registrar by submitting relevant membership details via **email to [membership@kism.or.ke](mailto:membership@kism.or.ke)** and a copy to **[registrar@kism.or.ke](mailto:registrar@kism.or.ke)** within the same period.

**BE ADVISED** that the Institute reserves the right to verify and authenticate all information provided by members. Any member found to have submitted **false or misleading information** shall be subjected to disciplinary action in accordance with the applicable laws and regulations governing the profession.

**ACCORDINGLY**, all Procurement and Supply Chain Management professionals are hereby reminded to regularize their **membership and practicing license for the year 2026** without any further delay.
